


When children are sick, the love of Mom and Dad really starts to shine through. In a heartbeat, parents go to extra

Which Lives Matter?

So which lives matter? I never thought that question could be so complicated. When the "Black Lives Matter" protests erupted in the wake of George Floyd's death, I said what I've always said. I wrote a devotion about God's love for all people. To me, it seemed simple: "All Lives Matter!" How naïve I am.

The next day, a sportscaster in California was fired for tweeting something terribly offensive. Do you know what he tweeted? "All Lives Matter!" Huh. I was missing something. I've since learned that to many people, saying "All Lives Matter" is an offensive way to dismissively disparage people's concerns about injustice in America. Does what you say really communicate what you think you're saying?

So which lives matter? How can God's people be guided on this sensitive issue? We can start by asking ourselves this: Does God say "All Lives Matter," or does he say that your specific life matters? The answer, of course, is "Yes!" God does both! Doesn't the clear Biblical truth of objective and subjective justification help us in this delicate matter? For whom did Jesus die? For all! For me!

At times, the Bible emphasizes that Jesus is the world's Savior. "For God so loved the world..." (John 3:16). "The Lamb of God who takes away the sin of the world" (John 1:29). "God was reconciling the world to himself in Christ..." (2 Corinthians 5:19). There are times—many times—when you tell

people that Jesus died for all. That objective truth drives away doubts. No one is excluded. All lives matter!


But I hope there are also times—many times—when you tell individuals that Jesus died for them. Think of how personally God delivers his gospel message: "Speak tenderly to Jerusalem..." (Isaiah 40:2). To the paralytic: "Take heart, son, your sins are forgiven" (Matthew

9:2). To the tax collector: "I tell you that this man ... went home justified" (Luke 18:14). To the sinful woman: "I tell you, her many sins have been forgiven—for she loved much" (Luke 7:47). Aren't those powerfully personal statements from Jesus? What Jesus did for all, he did for me. That subjective truth drives away doubts too. I need that! Disabled lives matter. Tax collector lives matter. Prostitute lives matter. People needed to hear that!

In the face of abortion, a Christian says, "Unborn lives matter!" If someone responds, "No, all lives matter," we'd say, "Yes, all lives matter, but that's not the point that needs to be emphasized right now. Unborn lives matter!" In the face of racial injustice, a Christian says, "Black lives matter!" In the middle of a pandemic, a Christian says, "Elderly lives matter!" To that tormented soul, a Christian says, "Your life matters!" It's very Biblical to comfort hurting hearts with how much their lives matter to God.

It takes wisdom to determine when it's best to emphasize the universal grace of God and when it's time to emphasize the personal grace God shows to individuals. So which lives matter? All lives matter. Black lives matter. Your life matters. May God grant us wisdom to clearly share his grace.




What is the most useful chapter in the Bible? Some may feel that Genesis 1 (Creation), Psalm 23 (the Good

Shepherd), I Corinthians 15 (Resurrection), or Revelation 22 (the Bible's final words) deserve that title. Yet, there is a case that Romans 8 may well earn that distinction. Living in an unsettled world, this chapter bears a timely message: "Take a breath. God says that it will be okay."

Romans 8 contains several well-known verses.

- There is now no condemnation for those who are in Christ Jesus. (v. 1)
- I consider that our present sufferings are not worth comparing with the glory that will be revealed in us. (ν. 18)
- If God is for us, who can be against us? (v. 31) Each one clearly states that God is in control. Nothing can separate us from his love.

The past five months have been difficult for everyone. I do not wish to minimize the impact that disease, the loss of livelihood, and restrictions on travel and socializing have had on people. Nor do I claim that there is no inequality in the world. Yet, if you look at all that has recently happened through the lens of Romans 8, you begin to understand that what God does is for our good and it will continue to be for our good even in trying times.



Have you considered the new opportunities for the gospel since mid-March? An avalanche of technology through streaming, YouTube and other social media has shared the saving message of Jesus with a figuratively captive audience. The seed of the Word has been planted. The Holy Spirit will cause it to grow as he sees fit.

Have you considered the new opportunities for personal spiritual growth? Once busy schedules are not as busy. There is more time to read God's Word, meditate on it, and pray.

Have you considered the new opportunities for godly living? Social isolation creates loneliness. This is a great time to reach out and check on others—especially those who have no one checking on them.

Romans 8 closes, "For I am convinced that neither death nor life, neither angels nor demons, neither the present nor the future, nor any powers, neither height nor depth, nor anything else in all creation, will be able to separate us from the love of God that is in Christ Jesus our Lord." "Take a breath. God says that it will be okay."

Lord, help us to "take a breath" knowing that you are in control.

Amen.

Good news on two fronts

The 2021 premium rates for the WELS VEBA Group Health Care Plan will not change compared to the current 2020 rates. In other words, the 2020 rates for all WELS VEBA health and dental plan options will remain in effect for 2021. The WELS VEBA health plan has experienced better-than-expected claims costs and investment returns over the past 18 months, which has allowed the WELS VEBA Commission to keep 2021 rates the same as they were in 2020. No significant changes to cost-sharing amounts (deductibles) or covered services are expected for the 2021 plan year.

In contrast to rising costs of healthcare nationwide, WELS VEBA rates will have increased by only four percent over the three-year period from 2019-21. This does not include the approximately \$4.2 million in savings passed on to participating sponsoring organizations during the previously announced August 2020 WELS VEBA premium holiday.

Mr. Joshua Peterman, director of Benefit Plans, says, "The Lord continues to bless WELS VEBA to provide the commission with the financial flexibility to hold the rates flat for 2021 while maintaining adequate plan reserves. The commission is pleased to provide this rate stability to help support WELS ministry efforts."

In addition, the WELS VEBA Commission has approved a limited open enrollment that will run from Nov. 2, 2020, through Nov. 30, 2020, for coverage effective Jan. 1, 2021. Eligible workers serving at sponsoring organizations with at least one active worker enrolled in the WELS VEBA health plan will have the opportunity to enroll for new coverage or make changes to their existing WELS VEBA coverage. Open enrollment materials will be mailed to eligible workers in late October.

Another piece of good news is that Congregation Mission Offerings (CMO) for June totaled \$1,795,803, an increase of 28.9 percent over June 2019. Year-to-date CMO is now \$9,480,520, 2 percent above prior year-to-date receipts and 1.9 percent above year-to-date subscriptions. We are thankful that the Lord has enabled our congregations and members to continue their generous support for the work we do together as a synod even in these challenging times.

MLC releases return-toschool plans

Martin Luther College (MLC), New Ulm, Minn., the WELS college of ministry, released its "Knights Return to Campus Plan" on July 17, after months of planning. Due to COVID-19 restrictions, MLC had to conclude its 2019–20 school via alternative/distance learning.

The plan calls for students to return to

the school's campus in New Ulm for the fall semester, with classes starting on Aug. 24. Most of the courses will be delivered in person, with less than 10 percent being a blend of online and in-person instruction. The campus will host only essential on-campus events and provide virtual alternatives for other events where possible. Only students, faculty, and staff will be able to participate in the on-campus events at this time.

In a letter of introduction to the plan, Rev. Richard Gurgel, MLC president, shares that the fall planning team spent "hours listening to government officials, health professionals, collegiate organizations, new and returning students and their families, our faculty and staff, and many others in our synod" before putting together the document.

"Our top priority is providing the highest level of safety and confidence in our campus learning environment, while adhering to the spiritual and educational standards WELS expects from its college of ministry," he says.

Students and administration will participate in daily screenings, including a temperature check. Isolation and quarantine procedures are in place for those who have symptoms for COVID-19, test positive, or have been in close contact with someone exhibiting symptoms or testing positive.

Campus officials say the plan may change as circumstances change. "We offer this plan trusting in God's gracious care for us in our Lord Jesus," says Gurgel. "At the same time, we also recognize that such trust does not diminish the responsibility God himself entrusts to us to be wise stewards of our health for the sake of our whole campus family as well as for the entire community of New Ulm."

The other ministerial education schools—Wisconsin Lutheran Seminary, Mequon, Wis.; Luther Preparatory School, Watertown, Wis.; and Michigan Lutheran Seminary, Saginaw, Mich.—are finalizing their return-to-school documents. As of right now all three schools are planning to have face-to-face, in-

person instruction on their campuses for the start of the 2020–21 school year, with classes starting the week of Aug. 24. All four schools concluded the 2019–20 school year via alternative/distance learning due to COVID-19.

"The faculty and staff at Martin Luther College have done a remarkable job pulling together the many plans and decisions that have to be made to open safely this fall," says Rev. Paul Prange, administrator of the Board for Ministerial Education. "We ask God's blessings on the faithful work of everyone at MLC and the other ministerial education schools, and we keep them in our prayers."
